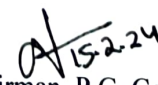

1. Acknowledge receipt towards deposit of admission fees, migration fees and registration & recognition fees through Payment Gateway.
2. All Original/Photocopies of Certificates and Mark Sheets from HSC onwards (Originals are to be returned after verification)
3. Original College Leaving and Conduct Certificates
4. Original Migration Certificate with requisite fee of Rs. 65/- towards Migration Fees and Registration & Recognition fees to be deposited through Payment Gateway under Examination Account Fees category.
5. Photocopy of "Aadhaar Card".
6. Six stamp size photographs
7. Original Certificate s in support of any special claim, such as SC/ST/PWD/Ex-Serviceman/NCC/NSS/Green Passage Scheme (to be returned after verification)
8. Original Residential Certificate for outside state.
9. Original Relive order from the employer in case of service holder.
10. Original Affidavit by the Student and Parents/Guardian from the Oath Commissioner.
