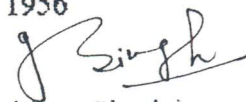

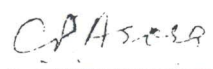

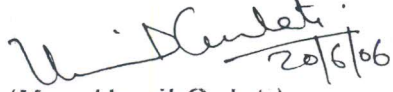
NOTIFICATION
