9. 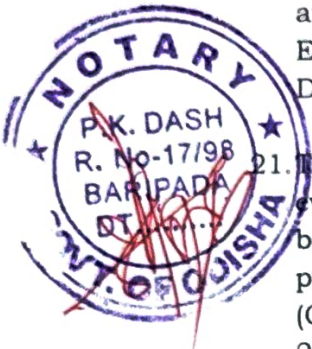

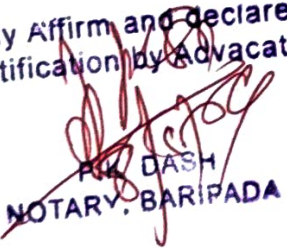
