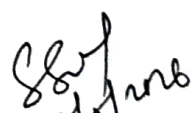
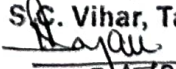


UNDERTAKING CUM DECLARATION

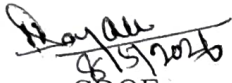

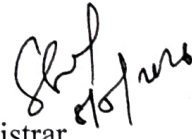
